***Academic Interventions Support 2009 PSAE Test Score Growth***  
**Congratulations to the Students and Staff of District 88!**

**EDUCATIONAL FOCUS ITEMS:**

- **Mrs. Beth Yacobi, Director of Curriculum & Learning**, provided a summary of **PSAE assessment data** from 2008-2009 for both Addison Trail and Willowbrook High Schools. The success of ATHS to achieve **Adequate Yearly Progress (AYP)** means students met or exceeded the 70.0% standard in Reading and Math (raised from 62.5% last year) for **No Child Left Behind (NCLB)**.

Although WBHS test scores are currently in an appeal process with the Illinois State Board of Education, results indicate the students and staff **experienced significant gains and continue to close the achievement gap**. In addition, this marks the first time that **District 88 has made AYP**, which is factored by the combined results of both schools.

Both schools are commended for their continuous work to raise student achievement. District 88 holds **high expectations for all students** and specific interventions are helping students gain the skills they need for success. Examples of these interventions include: increased graduation requirements, elimination of basic classes, credit recovery, summer school, math restructuring, practice tests and the work of all departments.

- **AT Summer School Coordinator Mr. Mike Phillips and WB Assistant Principal Ann Kimpton** presented data from the **2009 Summer School programs**. The Freshman Interventions program **targeted specific skills and raising achievement** for students below grade level in reading and math. Incoming freshman Algebra as a bridge to Geometry Honors and sophomore Geometry as a bridge to Advanced Algebra Honors were offered as well. Participation rates increased this year and students also experienced gains in their EXPLORE testing scores. The District will **work with feeder school districts to share results**. Sophomore and Junior Credit Recovery in math and English, ESL reading intervention, Speech, Consumer Education and Geometry were concurrent programs offered to help students achieve specific skills and provide greater schedule flexibility.

- Faculty members are scheduled to host upcoming “Warrior Code” student assemblies by grade level and communicate behavior and academic expectations.
- Upcoming events include: joint C.A.C. meeting, Open House and 50<sup>th</sup> anniversary celebration.

**SEPARATE ACTION ITEM**, following closed session, was approved by the Board:

- The Board voted to award a one month premium holiday for health insurance for the employer and employee which will be paid from reserves. The Board will review the possibility of awarding an additional premium holiday in six months.
