Bid Recommendation - Culvert Repairs at WBHS

We recommend that the Board of Education accept the lowest responsible and responsive base bid of \$114,441 from Hoppy's Landscaping, Inc. to complete the repairs to the culvert areas at the Willowbrook campus. We rebid this project with no change in scope of work and were able to secure four competitive bids (see attached). The estimated cost for the scope of work, according to Wight & Company, was \$108,332 including a contractors contingency of \$5,900. The low bid from Hoppy's Landscaping includes the required \$10,000 contingency allowance in their pricing so this is actually within the estimate provided. Any unexpected repair work will be covered from this allowance and the balance returned. The funding for this project was confirmed from our CLIC Insurance Cooperative for the full amount less our \$2,500 deductible. In addition, the temporary repair work, permits etc. are all covered from the insurance.

Wight & Co. has worked with this contractor before and confirms that they are prepared to meet the deadlines and perform the work as designed.

**Electricity Service Provider Change for 2013-14** 

As of the April 29, 2013 board meeting we were given authorization from the Board of Education to negotiate a new electricity service in anticipation of the current contract expiring December 2013. Given that this is a commodity, the rates change daily, so we needed this authority to lock in a rate and secure the contract. Therefore, at this time we are reporting that we secured a contract for electricity service for the estimated 10,737,134 kilowatt hours (kWh) of annual service to the district. Mr. Flemming and I worked closely with Entel, LLC which is the same energy broker that represents the Illinois Gas Cooperative where we purchase our natural gas service. Entel marketed our program consistently over the past five months until we were able to secure the best pricing. We secured a "fixed" rate of .0492 per kWh from Hudson Energy Services LLC for the next twelve (12) months through December 09, 2014. Although the market for electricity has trended up for the past year this is still a slight savings over our current rate of .04960. In addition, the previous rate had more variable components so we will definitely achieve some additional rate savings over the full term. As a comparison, we also know that one of the larger providers of this service to school districts is the Illinois Energy Cooperative (IEC) and their rate was recently confirmed at .05559kWh. Finally, with electricity expense representing approximately \$850,000 or 13% of the annual O&M Fund budget, we will continue to monitor the market and look to take advantage of any downward trend in pricing so we can lock in for a longer term to bring stability to our annual budgeting.

#### **Suggested Motion:**

Move that the Board of Education retroactively ratify the twelve (12) month agreement with Hudson Energy Services, LLC to purchase electricity at a price of .0492 per kWh.

**RECOMMENDATION - HIGHLANDER FIELD UPGRADE** 

The Village of Addison and the Board of Education of DuPage High School District 88 maintain the agreement and partnership established on August 2, 2010 for the Village owned property located at 555 N.
