Instructional Technology Presentation

Aaron Lenaghan, Director of Technology, Teaching and Learning, along with his team of Instructional Technology Coaches, Mrs. Jamie Gourley and Mr. Josh Zwart from Willowbrook, gave a presentation on how Instructional Technology tools are being utilized by staff and students. These instructional coaches demonstrated how Smartboards, interactive websites, online polling and texting are being integrated in the classroom.
