Public Hearing on the 2015 Tax Levy

The proposed tax levy for 2015 was reviewed during the October 26, 2015, and November 16, 2015, Board meetings. During the November 16, 2015, meeting, the Board adopted a resolution to establish the aggregate amount of taxes estimated to be levied for the year 2015 in the amount of \$53,510,050. That request represents a 4.9-percent increase, but we expect to receive an increase of about .96 percent based on the CPI at 0.8 percent and limited new-property growth. Because the value of total property and new property is unknown at this time, the district levied higher. No changes or updates were made since the proposed tax levy was approved in November. In compliance with the Truth in Taxation Law, a notice was published on December 3, 2015, that public comments would be heard at the December 14, 2015, meeting. The public hearing was opened during the December 14, 2015, Board meeting for Board members and audience members to ask questions and discuss the 2015 proposed tax levy.

Assessment Update

Mr. Adam Cibulka, Director of Curriculum, Instruction & Assessment, shared the results of the Partnership for Assessment of Readiness for College and Careers (PARCC) and further stated the district will administer the exam to students enrolled in Algebra I and English 9 in April 2016. The National ACT test will be offered on April 9, 2016, at both campuses. Students can register now, with a deadline of March 4, 2016. The state selected the SAT as the college entrance exam of choice moving forward, but no details are available for SAT or the new science assessment at this time.

Mr. Cibulka stressed this was the first year of the PARCC assessment and provided information on enhancements in the testing environment for the 2016 assessment.

Mr. Edward Hoster, Chief Financial Officer, reviewed the district's credit card use report for November 2015, as outlined in Board Policy 4:55 Use of Credit and Procurement Cards.

Bond Issuance Update Series 2015B New Borrowing

Jennifer Currier, Assistant Vice-President from PMA Securities, presented the final results of the new \$4,000,000 Working Cash Bond Issuance that was completed on November 24, 2015. The negotiated sale approach was successful, with a final borrowing interest cost of 2.67 percent, which is better than the estimate of 3.42 percent presented by PMA Securities in September. We were able to save approximately \$861,000 for the bond refunding earlier in November and apply that to the new borrowing. The combined final results indicate that we were able to borrow \$4,000,000, with a very low-interest cost of \$67,219 over the 10-year term.


