PMA PRESENTATION - BTF BOND ISSUE UPDATE

Linda Matkowski and Doreen Linderman from Public Finance Specialists (PMA) gave a bond market update. Given the current bond market volatility to overall credit/liquidity crisis and the DuPage County housing market situation, PMA is recommending the issuance of the remaining bonds for the Building The Future project. PMA is recommending two additional bond issues, December 2008 for \$10,000,000 and January 2009, for \$24,700,000.

Board gave their consensus to move forward for the issuance of the remaining bonds.

1. Package 15.4A & 15.4W Fire Protection

Mr. Welch explained that the scope review of the bid package 15.4W Fire Protection for Willowbrook is incomplete and is not being recommended or voted on.
