Academic Interventions Support 2008 PSAE Test Score Growth Congratulations to the Students and Staff of WBHS!

EDUCATIONAL FOCUS ITEMS:

• Mrs. Beth Yacobi, Director of Curriculum & Learning, provided a summary of PSAE assessment data from 2004-2008 for both Addison Trail and Willowbrook High Schools. The success of WBHS to achieve Adequate Yearly Progress (AYP) means students met or exceeded the 62.5% standard in Reading and Math (raised from 55% last year) for No Child Left Behind (NCLB).

Although AT test scores did not meet the benchmarks this year in all sub-categories, students and staff **experienced significant gains and continue to close the achievement gap.** In addition, the **District ACT average composite score** increased from 20.9 to 21.1.

Both schools are commended for their continuous work to raise student achievement. District 88 holds **high expectations for all students** and specific interventions are helping students gain the skills they need for success. Examples of these interventions include: increased graduation requirements, elimination of basic classes, credit recovery, summer school, math restructuring, practice tests and the work of all departments.

• Mrs. Yacobi also presented data from the 2008 Summer School programs. The Freshman Interventions program targeted specific skills and raising achievement for students below grade level in reading and math. The results from the 24 days of instruction will be forwarded on to all freshman teachers to continue providing support to these students. The District will work with feeder school districts and 8th grade families to understand the value of this work before starting high school. Sophomore and Junior seminar programs in math and English, ESL reading intervention, Speech, Consumer Education and Geometry were concurrent programs offered to help students achieve specific skills and provide greater schedule flexibility.

BUILDING THE FUTURE IN DISTRICT 88:

Superintendent Dr. Steve Humphrey reported that the 2008-2009 school year will open on time and that construction will take place year round with a continued emphasis on safety for the entire school community. Assistant Principals in each building have daily contact with the construction manager and will communicate important changes and information to students and staff.

Summer progress has been exciting, particularly in the area of technology with the **installation of a new wireless network.** The first phase of tablet laptops are expected to arrive soon and will begin changing the learning opportunities in the classroom. **District Office construction** continues in Addison and the relocation is scheduled for mid-October.
