Financial Reports:

1. <u>List of Bills – May 2011</u>

2. <u>Treasurer's Report - May 2011</u>

Prevailing Wage Resolution

Mr. Martin stated that the district is required to annually adopt the prevailing wage resolution, file it with the Secretary of State and publish a notice in the paper. The district works with other governmental agencies in Addison and Villa Park to publish one notice for all of the public bodies. It is recommended to adopt the prevailing wage resolutions.

Property/Casualty/Liability Insurance Renewal

Mr. Martin recommended that the board approve the payment of \$178,642 to the Collective Liability Insurance Cooperative for the 2011-2012 school year for property/casualty/liability insurance coverage. This is a 5.7% decrease from 2010-2011. The decrease can be attributed to a reduction in fixed costs and a return in surplus funds.

<u>Custodial Supplies Addison Trail, Willowbrook, District Office</u>

Mr. Martin recommended that authorization be given to approve the purchase of custodial supplies for Addison Trail and Willowbrook from the following vendors: Vega International, \$431.40; AmSan, \$1,110.64; Kranz, \$3,810.59; Unipak, \$4,828.30; Pyramid, \$6,583.90; HP Products, \$9,279.62; Expert Chemical, \$10,446.23, and Ramrod, \$25,664.97.
