Recognition of District 88 Successes

88's Best Students

88's Best Students Katerina Vassos from Addison Trail and Samuel Tumilty from Willowbrook were recognized for the month of April. The students were congratulated on their many accomplishments. The students thanked the Board, their teachers and their families for support.

Educational Focus Item

New Textbook Requests, Classroom Sets and Supplemental Instructional Materials

Dr. Jamie Gourley, Assistant Superintendent for Curriculum and Assessment, provided an overview of the New Textbook Requests and estimated Title I grant purchases of Classroom Sets of Textbooks and Supplemental Instructional Materials. This year will be the fourth year the district will be using federal Title I funds to purchase classroom sets of textbooks and supplemental instructional materials to support students and minimize the out of pocket cost to families. This summer, the district will invest approximately \$30,000 of Title I funds to purchase classroom sets of textbooks. The district is also looking to purchase an additional estimated \$135,000 in supplemental instructional materials for students.

Remote Learning Status Update

Dr. Jamie Gourley, Assistant Superintendent for Curriculum and Assessment, provided a status update on District 88 Remote Learning. Since April 6, 2020, staff and students have been engaging in remote learning in accordance to guidance from the Illinois State Board of Education. The presentation reviewed the current remote learning status on: attendance rates, e-Learning format and examples, PPS supports, professional development supports and virtual articulations and collaborations.
