Recognition of District 88 Successes

- 88's Best Students
88's Best students Joseph Valio, Jr., Addison Trail, and Melanie Ciancio, Willowbrook, were recognized for the month of May. The 88's Best recognition is given to one Addison Trail and one Willowbrook student each month to recognize those students' accomplishments inside the classroom and beyond.
- US News and World Report Academic Recognition
The US News & World Report recently released a comprehensive ranking of the "Nation's Best High Schools." They used a very rigorous system to create their ranking. Addison Trail was ranked at 1,454, and Willowbrook was ranked at 1,608 out of 22,000 schools nationally, placing both of our schools at the top 7% nationally. Out of 672 Illinois high schools, Addison Trail was ranked at 54, and Willowbrook was at 58, placing both schools in the top 8% in Illinois. District 88's incredible work with our students has been recognized nationally during the last several years in Newsweek, The Washington Post and now the US News & World Report.

- o State and National Student Recognition
Addison Trail and Willowbrook students who competed in State and National competitions during the 2011-12 school year were recognized at the Board meeting. Students from the FCCLA, BPA, DECA, SkillsUSA, Science Olympiad, IMEA, ICTM, National Champs Wrestlers, Career Readiness Certification and Special Olympics were recognized and congratulated for their accomplishments.

Custodial Supplies – Addison Trail/Willowbrook

Athletic Trainer – Addison Trail/Willowbrook

This item was tabled for further discussion until the May 21, 2012 Board meeting.

Certification of Hazardous Bus Conditions

Mr. Martin stated that the Illinois School Code requires that the Board of Education annually review areas within 1 ½ miles of school where free bus transportation is provided because conditions are such that walking constitutes a serious hazard. Currently, four such areas have been approved by the Illinois Department of Transportation:

- From North Entrance Kings Point to Junction of Rohlwing Road and Army Trail Road
- From Frontage on Rohlwing Road to Junction of Rohlwing Road and Army Trail Road
- Along Riordan Road from Ardmore Avenue to Monterey Avenue
- Along Ardmore Avenue from Roosevelt Road to Canterbury

It is recommended that the Board certify that the hazardous conditions in these areas remain unchanged and that walking continues to constitute a serious hazard to students due to vehicular traffic.
