

## Art Museum debuts new series in the McCormick House

ELMHURST — Continuing the museum's lively exploration of the Ludwig Mies van der Rohe-designed McCormick House located in Wilder Park, the Elmhurst Art Museum is premiering an ongoing exhibition series called "In the House."

On a regular basis, artists, designers and architects will be invited to respond to the modernist structure by producing a site-specific installation in the house that takes into consideration its unique space and history. These presentations encourage conversations between past and present and provide a rare opportunity for artists to work directly with and in this exceptional example of Mies van der Rohe's residential design.

The first artist invited to participate in the series is Laura Davis, a Chicago-based artist whose sculpture and installations examine the intersection of craft, design and art. In the House: Laura Davis was curated by EAM's Chief Curator Staci Boris and is on view at Elmhurst Art Museum now through January 11, 2015.

Davis approaches the McCormick House with a passion not only for the modernist style (minimal form, clean lines, industrial materials) but also with an awareness that in order for "less to be more," certain exclusions had to be made. Her installation Histrionic Restoration reinserts these omissions into



## Village of Villa Park acquires its own stump grinder

The Village of Villa Park recently purchased a 2014 Carlton Model 7500 stump grinder to remove tree stumps. The Villa Park Village Board authorized the \$47,750 purchase during the Aug. 25 board meeting.

The village purchased the unit—a demo unit with 96 hours of use—from Alexander Equipment Company Inc. of Lisle. The money for the purchase will be taken from the village's equipment replacement fund.

The village forestry division requested the purchase to remove stumps of trees killed by the emerald ash borer infestation. The village previously borrowed stump grinders from the forestry departments of Addison, Naperville

and River Forest.

According to Rich Salerno, Villa Park's superintendent of streets and forestry, a village crew used the newly purchased stump grinder to grind a total of 44 stumps in two days during the first week of September. Salerno said the crew's time is divided between tree removals, tree trimming and stump grinding. He said the village has also contracted with private companies for tree removals.

Villa Park forestry workers spent last week helping the Village of Palatine recover from recent storm damage. Salerno said he hopes the forestry crew will resume grinding stumps in Villa Park this week.



## Village buys stump grinder...

THE VILLA PARK VILLAGE BOARD recently authorized the \$47,750 purchase of a stump grinder (pictured above). Board members authorized the purchase at their Aug. 25 meeting. The village's forestry division requested the purchase of the device to grind stumps of trees that have been killed by the infestation of emerald ash borer. ## Rail project to cause delays on UP Metra West Line through Oct. 15

A major rail replacement project that began Monday is altering midday and weekend train schedules for Metra Union Pacific West Line riders

According to a news release issued by Metra, Union Pacific will replace the rail on nearly 13 miles of track between Kress Road (in West Chicago) and Elburn from Sept 15 through Oct 15. The work is taking place on Track No. 1, which regular Metra riders would know as the northernmost or inbound track. The rail was originally laid in 1980 and has reportedly reached the end of its useful life.

A construction schedule will be in effect throughout the project, with delays of 10 minutes expected for midday trains on weekdays and delays of 15 minutes for weekend routes. The news release stated that the nature of the replacement project and the amount of rail traffic in the corridor may lead to additional delays.

The construction schedules are posted on Metra's Web site at www.metrarail.com The site will provide updated information throughout the course of the project.

To minimize the impact on Metia Union Pacific West Line oders and shorten the time frame of the project, workers will be deployed seven days a week and plan to limit single-track operations to weekends Union Pacific plans to divert as much freight traffic as possible away from the corndor to reduce interference with passenger service.


