# Addison Trail offers organizations for parents, guardians

## Good way to get involved in your child's education

**ADDISON** — If you're a parent/guardian of an Addison Trail student and want to get more involved in your child's education, consider joining one of Addison Trail's parent volunteer groups or educational/informational groups.

Below is information about the parent organizations offered at Addison Trail:

**District 88 Foundation:** The District 88 Foundation is a member of the Partnership for Inspired Education (PIE) Foundation, a 501(c)(3) charitable organization that serves public school students in District 88, Addison Elementary School District 4, School District 45 and Salt Creek School District 48. Founded in 2009, PIE is designed to be the foundation that supports a long-term partnership with the community, businesses, schools and, most importantly, the children served. Funds raised by the foundations have been used to support District 88 students and staff members.

**Citizens Advisory Council (CAC):** CAC is an organization made up of parents, citizens of the Addison community, District 88 Board of Education members and the Principal. Members discuss current issues prevalent in the high school and are the liaisons between the community and the Board of Education to voice community concerns. If you would like more information about how to become a member of CAC, contact Lori Irvin in the Principal's office at 630-628-3302.

**Teacher-Parent Organization (TPO):** TPO is a group composed of teachers and parents, who help build a connection between home and school. TPO is responsible for the Spaghetti Dinner in February and for giving scholarships to Addison Trail students.

**Athletic Booster Club:** The Athletic Booster Club cheers for all Blazers who wear the Navy Blue and White of Addison Trail. The Athletic Booster Club runs the concession stands year round and is always in need of an extra set of hands to help. For each hour of volunteering, you will earn money to be used by your student's coach/advisor for uniforms, individual team spirit wear, etc. The club also sells Blazer Wear to promote Blazer Pride among students, parents and staff. The

club supports service projects throughout the community by Addison Trail athletes as well. In the spring, the club offers scholarships to senior varsity athletes who meet the criteria.

**Music Booster Club:** The Music Booster Club is composed of parents of students who are involved in the Addison Trail music program. ## Cupola at former hospital comes down

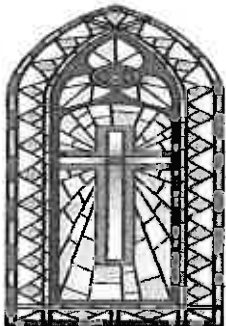

## Nick Trojanowicz coaches Junior Bulls wheelchair B-Ball

### ATHS grad shows not even a genetic disorder can slow him down

**ADDISON** — When watching Nick Trojanowicz coach his basketball team, he's just like any other coach — he demonstrates proper technique, keeps the players focused and offers words of encouragement.

But Trojanowicz is dealing with a challenge most people never have to face. Since birth, he has been battling neurofibromatosis, a genetically inherited disorder in which the nerve tissue grows tumors.

Trojanowicz attended Addison Trail and is now a student in District 88's Transition Program, which helps students ages 19 to 21 learn life skills, obtain job training in a community setting and successfully transition to adult life.

Now age 21, Trojanowicz has undergone chemotherapy, 18 surgeries and the amputation of one of his legs to try and fight the cancerous tumor that's wrapped around his body. But he doesn't let his condition slow him down. For about nine years, Trojanowicz has been involved in wheelchair basketball, archery, golf and track and field through Northeast DuPage Special Recreation Association (NEDSRA). And this year, he's moving on to the next phase in sports — coaching.

"It has been great," he said of coaching the Junior Bulls Wheelchair Team, which is now part of Synergy. "I'm liking it a lot."

He said his favorite aspect of coaching is helping the athletes improve, and he enjoys sharing his expertise with them.

"I want to help each player get stronger and better," he said.

He added that he can't wait for the team's first tournament, which will take place in December.

His mother, Diana Glatchak, said she can't describe in words how proud she feels when she watches him coach.

"When people ask me who my hero is, I point to Nick and tell them, 'I'm looking at him,'" she said. "He's just incredible."

She added it's bittersweet to see Trojanowicz advance to this stage of his athletic career.

"I remember when he was just starting out on the team," she said. "To watch him go from making his first basket to helping other kids have that experience is indescribable."

## Elmhurst College's student newspapers stolen from stands

### May have been attempt to cover up sorority's hazing incident

ELMHURST — Last week, the Independent learned that at least 800 copies of the student newspaper published at Elmhurst College had been removed from newsstands on the morning of Tuesday, October 7.

According to a story later published in The Leader, the student-operated campus newspaper, several copies of the paper were found in garbage cans and compost bins around campus.

A front page article on the October 7th issue of The Leader reported information about an alleged hazing incident, which reportedly took place at the Phi Mu sorority chapter. The reporting of that incident is believed to be the reason the papers were taken and thrown away, according to the newspaper's editorial board.

Some students at the college reportedly observed members of the Phi Mu sorority, throwing out the Oct. 7 issue at several locations on campus.

"I cannot believe people thought they were justified in stealing our newspapers just because they didn't like an article we reported," editor-in-chief Zachary Bishop said. "My staff's hours of work have been wasted and our freedom of press has been suppressed."

"We will not forget about this injustice."

The missing copies were reported to campus security at Elmhurst College the same day and officers are currently conducting an investigation on behalf of the English Department.

The estimated cost for the missing copies is more than \$1,000.

## Addison Trail clinches tie for conference title

The Addison Trail football team can do no worse than tying for the West Suburban Conference Gold Division title.

The Blazers scored a recent 42-7 WSC Gold win over Proviso East. That win moved Addison Trail to a perfect 7-0 and 5-0 in WSC Gold play.

Addison Trail still holds a one-game lead in the division over both Hinsdale South (3-1) and Downers Grove South (3-1).

The Blazers will play their annual WSC crossover game against unbeaten Glenbard West (7-0) Saturday in Glen Ellyn and then finish up conference play against District 88 neighbor Willowbrook (1-6) in Week 9.

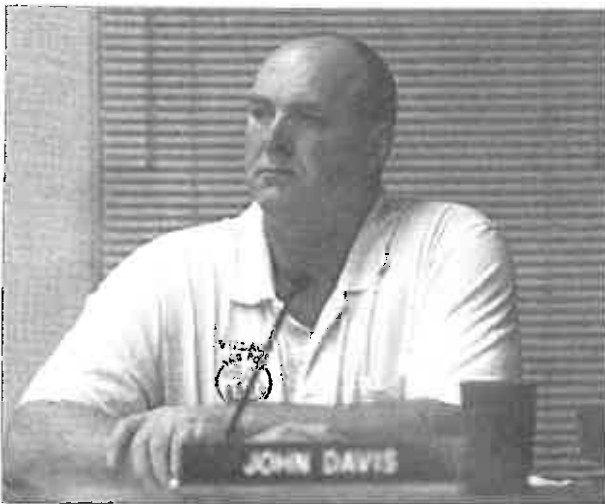

The above photo shows Davis at the beginning of Monday night's board meeting--Davis' final meeting as a member of the board. Davis stated after the meeting that he is resigning for health reasons. Davis was the senior member of the current village board, which includes six trustees and the village president. He was appointed in the fall of 2006 and elected to fill out a two-year term in the spring of 2007. Davis was re-elected to four-year terms in 2009 and 2013. Villa Park Village President Deborah Bullwinkel announced during the end of Monday's meeting that she will not appoint anyone to serve the remaining time (more than two years) of Davis' current term. Voters will decide who will serve out the term during the election of April 7, 2015. The four-year terms of three Villa Park trustees (Chris Aiello, Albert Bulthuis and Donald Kase) end in 2015.

## Trustee John Davis resigns from the Villa Park village board

Villa Park Village Trustee John Davis ended nearly nine years of service on the village board at Monday's board meeting. Citing health reasons, Davis resigned from the board, effective immediately.

"I'm stepping down for medical reasons," said Davis following the end of the board meeting. "I've had four back surgeries since I've been up here [on the village board]. I have other health issues, so it's time to step down. It's at the point where I'd have to start missing meetings. That's not fair to residents. You can't represent them if you're not here."

Davis also said after the meeting his Villa Park home is for sale. He stated that he decided to resign from the board before he put his house on the market.

"Moving had nothing to do with this," said Davis of his decision to leave the board.

Davis joined the board in November 2006. Joyce Stupigia, who was Villa Park's village president at the time, appointed Davis to fill a vacancy on the board. Months later, in April 2007, Davis was elected to serve the remaining two years of the vacated position. Davis won four-year terms in the elections of 2009 and 2013.

He edged Tony Gurdak by three votes in the 2013 race for the third and final available seat on the board. The official results showed Davis with 1,462 votes and Gurdak with 1,459 votes.

Villa Park Village President Deborah Bullwinkel noted at the end of Monday's meeting that she had the option to appoint a successor (with approval from the board) to fill the remaining two-plus years of Davis' current term. She said, however, that she has decided to let voters decide who should replace Davis. There will be an election to serve the remainder of that seat during the election of April 7, 2015. Voters in next year's election will also choose three fellow residents to serve four-year terms on the board. The four-year terms of current trustees Chris Aiello, Albert Bulthuis and Donald Kase expire next year.

Davis read a statement as he announced his resignation near the end of Monday's meeting.

"Serving on the board of trustees has been a fulfilling learning experience for me," said Davis, who thanked Villa Park residents for allowing him to serve on the board. "I have enjoyed my time as a member of the board. I took being a trustee very seriously."

## Victim reportedly robbed on the Great Western Trail

### Male offender reportedly used electric device on the victim

Villa Park Police are investigating an alleged robbery that reportedly took place on the Great Western Trail on Oct. 22.

According to a news release issued by the Villa Park Police Department, a male victim reported that he was walking on the trail just east of Harvard Avenue after 6 p.m. when he was approached by a male subject. The victim alleged that he was struck with an electric defense device, which caused him to fall to the ground. The male subject reportedly took the victim's wallet and fled with another subject, heading westbound on the trail.

The victim reportedly waited about 30 minutes to call 9-1-1. Responding officers searched the area but did not locate any suspects.

The victim reported that he found his wallet one day later while searching a wooded area on the trail one block west of Harvard.

The suspect was described as white, approximately 18-25 years old, approximately 6 feet tall, weighing 140 to 160 pounds, with blonde hair, wearing dark colored jeans with a

dark colored hooded sweatshirt. The suspect was also wearing a scarf that covered his face. The victim was unable to give a description of the second suspect.

Police also announced that they are investigating two incidents of indecent exposure involving a male subject driving a vehicle who exposed himself on two separate occasions. The first incident reportedly took place May 12 in the area of Washington and Yale. The second incident occurred at about 9:20 a.m. on Oct. 21, in the area of Washington and Cornell. In both incidents, the suspect reportedly stopped and asked a female victim for directions to Roosevelt Road before exposing himself.

The male suspect is described as Hispanic, approximately 30 years old, with a round face with no facial hair, wearing a black hat and a dark-colored jacket. He was reportedly driving an older-model, cream-colored four-door sedan.

In addition, Villa Park Police Chief Robert Pavelchik stated that additional police personnel will be available to assist residents during the four-hour trick-or-treating period. Pavelchik encourages parents to make sure that their children trick-or-treat only during those hours.

Chief Pavelchik recommends that parents take a few simple steps to help ensure their children's safety during Halloween.

• Young children should be accompanied by a responsible adult. No child should ever

trick-or-treat alone. Children should walk only in well-lighted areas and avoid backyards, alleys, empty lots and parks.

• Make sure that any masks that are worn do not block a child's vision. They should be able to see well both in front and to each side.

• Children who trick-or-treat after dark should carry flashlights and use reflective tape on their costumes.

• Parents of older children should know the routes they are planning to take and set a time for kids to be home. It is strongly recommended that children go out in groups rather than by themselves.

• Review the contents of all treats. Remove any suspicious treats. If any treats show signs of possible tampering, call the police department at 630-834-7447.

Addison Trail junior Ryan Sygowicz did not take over the football team's quarterback position under the most ideal of conditions.

"I'm better at reading different defenses," he said. "Going into high school I had no idea how any of that worked. The coaches here have really helped me with that and worked with me to get better at that. The work I've put in has helped out greatly."

"I like throwing the ball," said Sygowicz, who came up through the Addison Cowboys youth football program. "I

Sygowicz enjoys watching Green Bay Packers quarterback Aaron Rodgers perform. "I like the way he handles the game and stays in the pocket," he said. "If there is a breakdown, he still can make a play for his team. He really handles himself well."

**An interview with the swimming standout...**

**VILLA PARK** — For more than a decade, the swimming pool has been Kelly McNamara's second home.

And for the past four years, the Addison Trail-Willowbrook Girls Swim Team has been her second family. McNamara, a senior at Willowbrook, has had a slew of successes during her high school swimming career — most notably winning a silver medal in the 100-yard butterfly during last year's Illinois High School Association (IHSA) Girls Swimming & Diving State meet and being named as an All-American this past spring. Athletes who receive that honor are in the top 100 high school swimmers in the U.S. for a given event.

As McNamara heads into the championship portion of her final high school season, she's focused on making a repeat appearance at State on Nov. 21

and 22. She hopes to compete in the 50-yard freestyle; the 200-yard medley relay and the 200-yard freestyle relay with Willowbrook senior Molly Hill; Addison Trail senior Gabriela Morrone and Willowbrook junior Meghan Koterba; and, of course, the 100-yard butterfly.

District 88 recently sat down with McNamara to talk about her final season, her future plans and what she has learned from more than 10 years of swimming.

**Q. Going into your last high school season, have you approached anything differently this year?**

A. I swam a lot during the summer to make sure I was ready to go when the season started. It's definitely a little different this year because it's my last chance to perform well. But I'm feeling confident, and I just want to enjoy my last year with the Addison Trail-Willowbrook Team.

**Q. Your coach, Paul Anderson, has said you routinely exceed his expectations. What motivates you to continue getting in the pool every day?**

A. (Laughs) I honestly don't know. It's not easy work, that's for sure. It's a lot of time, energy and commitment. We condition nearly every morning and practice almost every afternoon, so it's tough. But I just keep going — it's part of my life and part of who I am.

**Q. That hard work certainly seems to have paid off. You had quite a successful season last year. What does it mean to you to receive those awards?**

A. It's pretty cool. We all put in a lot of dedication, and it's nice to be recognized for your efforts.

**Q. Through the last four years, you seem to have grown into a leadership role on the team. What impact do you hope you've had on your teammates?**

A. I hope I help motivate everyone to stay positive and encourage them. We have an extra challenge with not having a pool at our school, so I try to make sure everyone keeps an upbeat attitude. We spend a lot of time traveling to the pool at Club Fitness in Addison when we could be swimming, which can be frustrating. I try to set a good example of overcoming that adversity. I always tell them not to take it too seriously and to have fun.

**Q. What are your future plans?**

A. I'm looking into The University of Iowa, University of Kentucky, Indiana University and University of Minnesota. I'm not sure which major I want to pursue, but I do plan to continue swimming.

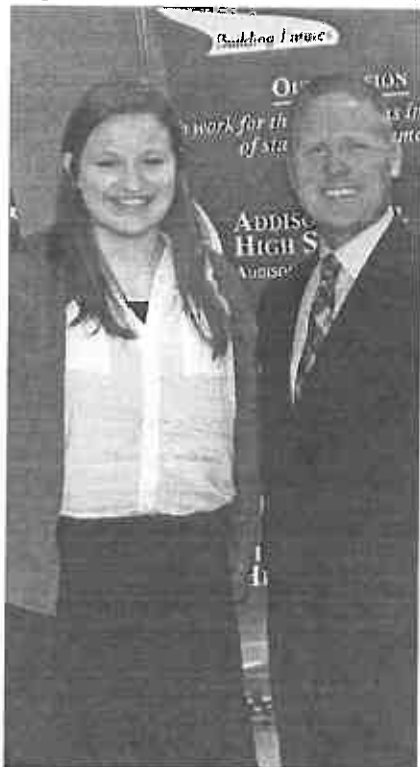

"I think the Mayor's Ball is really the best example of who we are in Addison," said Mayor Rich Veenstra. "We come together, we cooperate, and we help each other out."

There are 18 different local charities and service organizations that use the Mayor's Ball as a major fundraiser; all proceeds are used by these organizations to help the community.

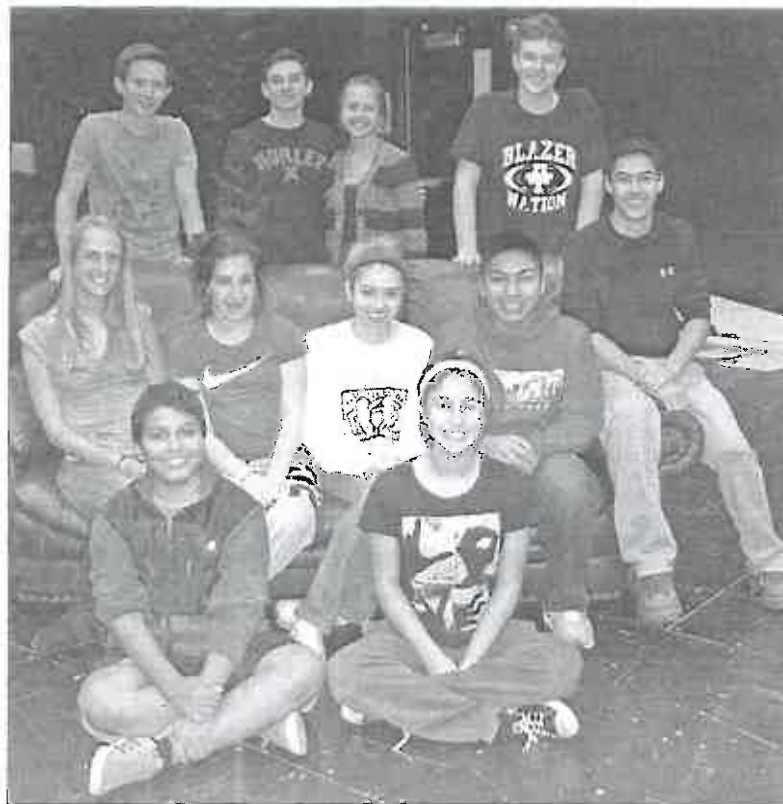

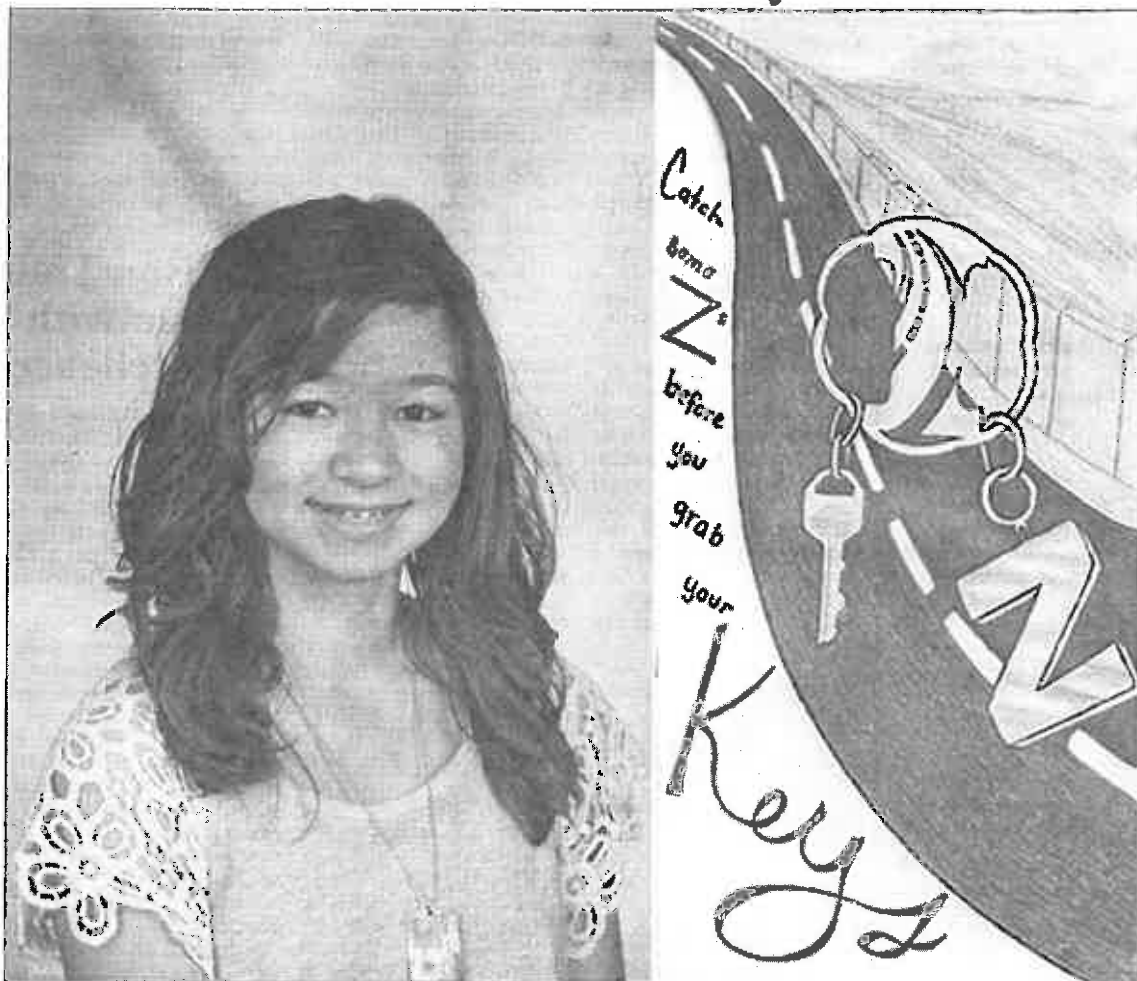
ADDISON — Addison Trail senior Cassandra Terrill has been named as a semifinalist in the Illinois Tollway 2015 Map Cover Art Contest.

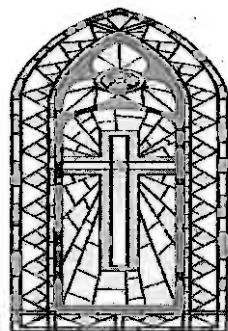

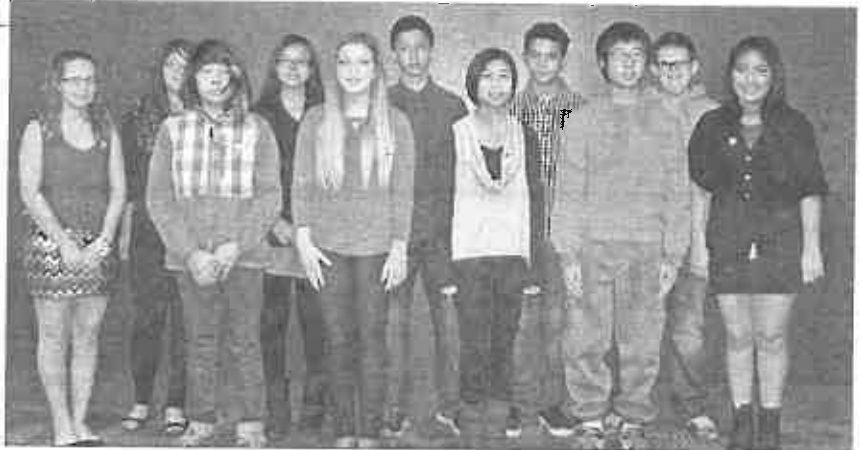
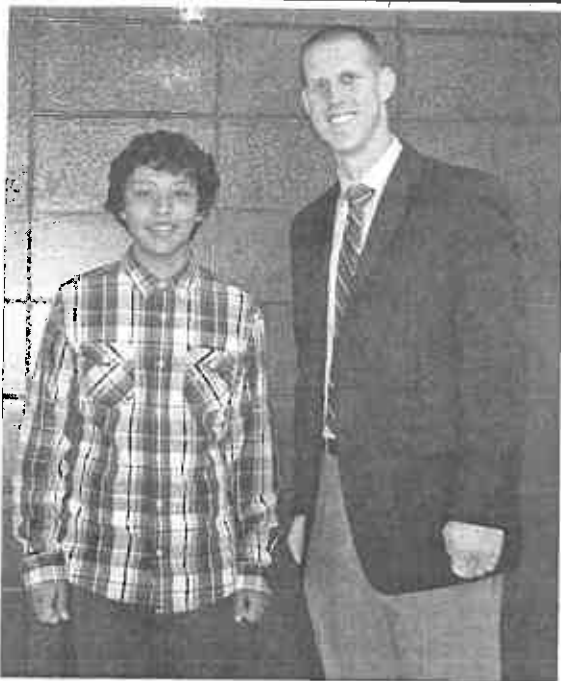
After graduation, Villalobos plans to attend college and major in engineering. She is still undecided about which school she will attend, and she is applying to many different schools.

# Thrust into the spotlight

*Junior Ryan Sygowicz is ready for the challenge of being Addison Trail's quarterback*

Addison Trail junior Ryan Sygowicz did not take over the football team's quarterback position under the most ideal of conditions.

**ELMHURST** – York's push for the postseason ended Oct. 24 with a lopsided home loss against undefeated Glenbard West.

It was the third straight loss for the Dukes, which finished the season 4-5, needing just one more win to become postseason eligible. The 48-7 loss against the Hilltoppers capped off the first season under coach Matt Monken.

A win against Glenbard West would have made York the last team to get in the playoff field. Instead, the Dukes missed the postseason for the third straight year. It is the first three-year playoff drought for York football since the program's first playoff appearance in 1985.

Despite failing to make the postseason, there were signs of improvement this fall, starting with the win total. The four wins are more than the previous two years combined.

Junior running back Lucas Alexander had York's

**ADDISON** – After a dream regular season, Addison Trail now enters the postseason with a powerhouse program awaiting.

The Blazers, who beat rival Willowbrook 27-17 in the regular season finale to finish 8-1 and undefeated in the West Suburban Gold, open the Class 7A playoffs against Lake Zurich.

The Bears have made the playoffs 13 straight years and have made the semifinals the past five seasons, including runner-up finishes last year and in 2010. This year, however, the Bears went just 5-4, the worst regular season the program has had since 2005.

"I watched film on them and they look like a really well put together team," AT senior linebacker Michael Peters said. "They played some hard teams this year so their record doesn't show how good they really are."

Lake Zurich played six play-

off teams and went 2-4 against those teams. The Bears beat Fremd 10-7 in the season opener and picked up a 35-24 North Suburban Lake conference win against Lake Forest in Week 7.

Running backs Ben Klett and Zane Lodico lead the Bears' run-heavy offense. The Bears exploded for 35 or more points four times this season, but were limited to under 20 five times and lost four of those games.

In their recent run of success, Lake Zurich has been more known for its defense. This season they limited opponents to just under 17 points per game. AT's defense al-

lowed just under 13 points per game in the regular season.

"I heard they're a good football team, but it shouldn't be a problem," senior wide receiver Jake Atiyeh said. "We should just do what we do and not really pay too much attention to what they're doing. Just get more focused on getting our job done and we should come out with a win."

The Blazers' win against Willowbrook was the first start for junior quarterback Ryan Zigowicz, who played in place of injured starter Mike Rybarczyk. Zigowicz was 12-for-16 for 130 yards against the Warriors with one interception and one fumble. What AT likely loses without Rybarczyk is the dual threat ability. Rybarczyk ran for nine touchdowns in his eight games.

Starting running back Malik Pierre-Louis sat out for the third straight game, but is on track for a return against Lake Zurich. Mike Hundley had the game-breaking 94-yard run in

the fourth quarter to put the Blazers ahead against Willowbrook and finished with 301 yards rushing on 30 carries.

AT scored a pair of touchdowns to take a 12-0 lead in the second quarter, but Willowbrook led 14-12 at halftime. That lead stood until a pair of fourth quarter touchdowns by the Blazers.

"We had some kinks, but we're hoping to work them out in the week of practice," Atiyeh said. "[Zigowicz] had some nerves coming into the game so I think just with his first game under his belt I think he'll be smoother and we'll just execute better in the next game."

This is Addison Trail's first playoff appearance since 2011. In the two years in between the Blazers went 2-7 both seasons.

"Coming from last year when we did terrible, to come back this year and go 8-1 in the regular season and now we're coming into the playoffs, it's a huge turnaround," Peters said. "It feels great."
