ELMHURST - After spending four years on varsity, IC Catholic softball seniors Jessica Conenna and Gabby Curran are hoping they can end their careers at state.

The two have signed to extend their softball careers in college, but first they want to guide the Knights to the promised land. Conenna, a standout two-way pitcher who will pitch at Northern Illinois, and Curran, a shortstop committed to Dominican University, both believe the Knights have what it takes.

"I just think overall we're playing the best throughout my four years," Conenna said. "We're all around more versatile and all around closer together.'

IC entered Thursday's game against Fenton with a 19-3 record. The Knights re2A regional, which they will host starting May 18.

After making it to a sectional final last year, the Knights are hungry for more.

"I really think we do have the talent to go downstate and I think that would be a great way to end senior year," Curran said. "We've always had a lot of talent here, but for the past four years we've been struggling with it a little bit. We really put it together this year. It's great to see all the rewards from all the hard work we put in."

Conenna has a 1.78 ERA with five shutouts and 130 strikeouts, including seven outings with 10 or more strikeouts. this season. She's also hitting .419 with 24 RBIs in 20 games.

"I just want to make this season count and make it memorable," Conenna said. "I think I'm just more determined on the mound as a senior. I'm

Meanwhile, Curran is earning her leadoff spot in the order with a .519 batting average, 21 stolen bases and 35 runs scored.

impact: Falduto was on varsity last year, but has become an everyday player in the lineup at second base this season. She is one of the team's most improved play-







Warriors finish conference dualmeet season with perfect 4-0 mark

The Willowbrook boys gymnastics team is poised to make some bog noise the next few weeks.

The Warriors finished West
Suburban Conference Gold
Division dual-meet action with
a perfect 4-0 mark and posted
a season-high 146.3 team score
in a recent WSC Gold victory
over Downers Grove South.

"We're having a great season," said Willowbrook coach John Wronkiewicz. Wronkiewicz noted the recipe for the team's success in 2015 boils down to two key factors.

"We have stayed healthy and we're doing good gymnastics," he said. "We have three good all-around gymnasts and the rest of the team is built around them."

Those three all-around talents include seniors Keawe Winstead and Bret Golz along with freshman Adam Sousa. Winstead, a state qualifier last year, was a sectional champion as well last spring on pommel horse.

Wronkiewicz said Sousa is around 50 right now with his all-around score, while Winstead and Golz are in the 47 range.

Sophomore Bailey Heppner, a two-year gymnast and another all-arounder, also has made an impact for the War-

riors, who headed into last week's West Suburban Conference Gold Division meet seeking their second league title in three years.

"Bailey is doing a nice job progressing in the sport," said Wronkiewicz.

The coach also lauded the work of the Willowbrook junior-varsity team.

"We have a strong junior varsity," said Wronkiewicz. "We'll take strong IV guys and plug them into certain events in the dual meets."

Willowbrook has thrived in the horse and horizontal bar events. "Hi-bar and pommel horse have been our strongest events," said Wronkiewicz. "That's huge because those usually are the events teams struggle with the most. Our guys have been very good in those events."

Wronkiewicz said team unity also must be factored into his team's success package. "It's a well-bonded team that gets along so well," he said. "It's like one big family here of brothers. They look out for each other. They all want each other to do well. That's one big

The Addison Trail boys track team continued its strong showing by winning the recent Glenbard South Invitational.

It was the Blazers' second invitational title in a row. Addison Trail also won the Elgin Invitational. In winning the Elgin Invitational, the Blazers set meet and school records for most team points scored with 322 (Addison Trail finished 30 points ahead of second-place Maine West). The Elgin meet was scored in an A-B-C format which allowed for multiple relays per relay event as well as points being awarded at all three levels and then being summed into one grand-total score.

Addison Trail won the Glenbard South title with only three first-place finishes. "Our depth was very evident," said Addison Trail coach Bruce Kelsay, who noted the team scored points in almost every running event."

The Blazers were behind by three points in the team standings with two events remaining and secured the team championship thanks to a second- and third-place finishes in the 200 and a victory in the 1,600 relay.

Darrion Conrad was second in the 200 and brother, Darius, was third in the event.

Addison Trail's first-place 1,600 relay team included Rayan Baig, Donovan Granados, Albino Lucero and Darius Perez.

Jordyn Cart-Jones won the

110 high hurdles for the Blazers, while the 800 relay team of Baig, Taylor White, Darius Conrad and Darrion Conrad also took first.

Pytko said the team's relays have been improving and so has Alyssa Viera in the throws. She's gone over 100 feet in the discus this spring.

Relay-wise Pytko said the 400 and 800 relay teams of Klea Gjonaj, Kim Schonder, Maria D'Ugo and Kroll have been making progress.

Pytko added the frosh-soph group of athletes has been making positive strides as well.

"The frosh-soph team is doing well. They are sticking together as a unit," he said. "I can't say enough about them. They are learning how to run. A lot of them are so new to track. They are putting in a lot of hard work and I'm working hard with them as well."

Looking ahead, Pytko feels the team has the potential to have several sectional medalists.

"I don't know how close we are going to come to state-qualifying times, but we will have some respectable times to where we have the chance to medal in the sectional meet," he said.

Pytko is hopeful Banuelos and Suhei Valbuena can both go under 1:00 in the 400 race. He added Kroll, who is running the 200, could switch to the 100 at sectionals.

The Warriors earned 16 personal records and came home with five individual champions.

"We currently are running our athletes at their level," explained Willowbrook coach TJ Artman. "The freshmen are running in the freshman races and the sophomores in the sophomore races. It puts some holes in our lineup but we want the boys to experience competition at their level and have some fun being out front."

At Glenbard South, Jimmy Funteas Jr. won the 800 varsity title. At the sophomore level, Eddie Tribue won the 100 and 200 races, while Casey King won the 800 and Freddie Clay won the 400.

Artman has been pleased

with the progress seniors Funteas Jr. and Donnie Hawkins have been making. "Donnie in the 300 hurdles and 200 and 400 dashes is racing his fastest times of the season and his career right now," said Artman. "He is an integral part of our sprint relays and is a captain.'

Funteas Jr. is a major presence for the Warriors in the 3,200, 800 and 1,600 races. "Jimmy is on the verge of breaking two minutes in the 800," said Artman. "That's a major mental barrier He's looking great training-wise as we head into the county, conference and sectional races."

Juniors Josan Murphy and Marco Martinez are two additional cogs in the Warriors' lineup. Murphy, a sprinter, had been sidelined with an injury for two weeks but was expected to return last week for Willowbrook's home meet, Artman

"Josan should be off and racing with no problem," Artman

Martinez, who runs distance races for Willowbrook, ran well at Glenbard South amidst pour-

ing rain conditions. "Marco ran our fastest mile at Glenbard South in nasty conditions," said Artman. "He's coming along nicely. Marco is a great kid with a huge competitive attitude.'

King and Tribue, who starred at Glenbard South, are two young talents Artman has high hopes for. "Casey is a distance runner and jumper," the coach noted. "His 800 time is dropping and his triple jump is getting further. We're running him on the lower levels for now, but he will find himself on the

varsity when the time comes. Eddie is a sprinter who brings the speed in any event we put him in. Like Casey, he will find himself racing with the big boys in the big meets.'

Artman is looking forward to

the upcoming big meets.
"Our end of the season is shaping up nicely. We are excited and ready to race at the county meet, the conference meet at Morton and the sectional back at York," said Artman. "It's going to be a fun and exciting time of the year
