

Board Approves 2009 Tax Levy Resolution

SEPARATE ACTION ITEMS approved by the Board:

- **Adopted the tentative 2009 tax levy resolution and established the public hearing** date for the 2009 tax levy of Monday, December 14, 2009 at 7:30 p.m. in the District Board Room.
- **Ratification of BTF Planning/Construction Committee Actions** including Change Event #W147-001 for Connelly Electric, Change Event #A127-003 for DuPage Topsoil and Change Event #A127-006 for O'Donovan and Sons, Inc.
