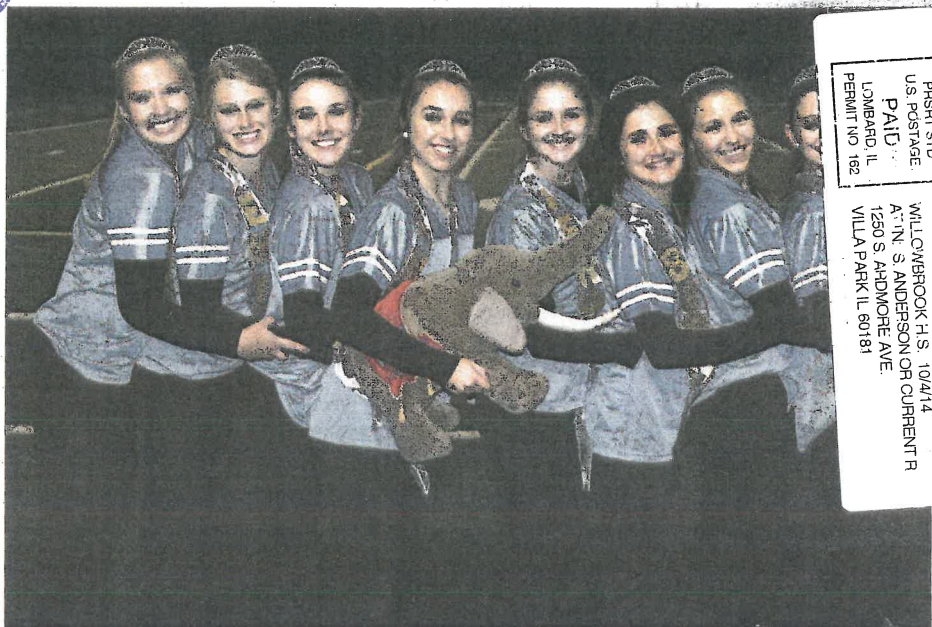


## Senior poms...

## VPFD holds open house during Fire Prevention Week

The Villa Park Fire Department welcomed guests to its annual open house on Saturday afternoon at Fire Station No. 81 at 1440 S. Ardmore Ave. Visitors included numerous children, who were able to use a fire hose, dress up in firefighting gear and climb inside emergency vehicles. The open house ended with a live fire demonstration that showed how quickly a fire can spread.

The open house takes place during Fire Prevention Week, which is sponsored by the National Fire Protection Association (NFPA). Fire Prevention Week, which dates back to the 1920s, is held in early October to commemorate the Great Chicago Fire, which began on Oct. 8, 1871.

The theme of this year's Fire Prevention Week (Oct. 4-10) was "Every Bedroom Needs a Working Smoke Alarm." According to the National Fire Protection Association (NFPA), roughly half of home fire deaths result from fires reported between 11 p.m. and 7 a.m., when most people are asleep. The NFPA recommends the installation of smoke alarms in every bedroom of residences and on every level of a home, including the basement.

Villa Park Fire Lt. Chris Gilliland spoke right before the live fire demonstration. Gilliland urged the spectators to check the smoke alarms in their residences when they returned home to make sure the alarms are working properly.

The smoke alarm inside the space went off about 15 seconds after the fire began. In addition to seeing the fire burn, spectators could feel the intense heat from the blaze.

## Villa Park's seven-week unlimited fall leaf collection begins next week

Yard waste stickers aren't required from Oct. 19 through Dec. 4

The Village of Villa Park's fall leaf collection program will allow residents to dispose of an unlimited number of Kraft paper bags of leaves without affixing yard waste disposal stickers. The program will be in effect during a seven-week period from beginning next week (the week of Monday, Oct. 19) and ending the week of Nov. 30 to Dec. 4.

Brush must be tied in bundles no longer than 4 feet and not larger than 18 inches in diameter. No limbs over 4 inches in diameter

will be accepted.

Yard waste stickers are not required for the disposal of brush bundles. Since all brush and yard waste are transported to a composting facility for processing, plastic bags may not be used. Residents should use only biodegradable twine or string for binding brush.

It is unlawful to deposit yard waste of any kind into public streets.

The 5-kilometer run/walk will start at 9 a.m. The shorter race for children will begin at 10 a.m.

Race-day registration will start at 7 a.m. All proceeds from the event will benefit the local charities, organizations and families

supported by the Villa Park Junior Women's Club.

Participants in each event are encouraged to wear Halloween costumes. There will be prizes for the fastest male and female finishers, as well as those who are judged to have the best costumes.

## Police department announces upcoming roadside safety checks

The Villa Park Police Department announced last week it will conduct roadside safety checks on Friday, Oct. 23; Saturday, Nov. 14 and Friday, Nov. 20. According to a news release issued by the police department, the safety checks are being conducted to promote the safety and well-being of the motoring public, and to provide a deterrent for those who might violate Illinois Vehicle Code statutes and village ordinances.

The release noted that the department plans to conduct the checks at locations and time periods that will provide the maximum opportunity for the detection and apprehension of motorists who drive under the influence of alcohol or other substances. The department stated that the roadside safety checks will be conducted according to the guidelines set forth by the courts.

## Willowbrook music department presents four events this month

The Willowbrook music department will present four events in October, beginning with the collage concert in the school auditorium on Thursday, Oct. 15. The concert, which will feature the school's band, orchestra and choir groups, will start at 7 p.m. Tickets may be purchased at the door for the collage concert. Admission is \$3 for adults and \$2 for students. The collage concert is a benefit and no passes will be accepted. The Willowbrook Music Boosters will be sponsoring a bake sale at the event. All proceeds will go toward the boosters' scholarship fund.

Willowbrook's marching band will join musicians from area grade schools to perform at halftime of the Warriors' Oct. 16 varsity home football game against Downers Grove South. The halftime presentation takes place on Willowbrook's 21st annual Band Day.

Musicians from Albright, Jackson and

Jefferson middle schools will join Willowbrook's artists for a combined performance at the annual string festival concert on Thursday, Oct. 22. The free concert begins at 7 p.m. in the Willowbrook auditorium.

The Willowbrook choir will join the choirs from area grade schools for a combined performance choir invitational on Tuesday, Oct. 27—another free event that begins at 7 p.m. in the auditorium.

## Villa Park sets its Halloween trick-or-treating hours; 3-7 p.m.

The Villa Park Village Board has adopted Saturday, Oct. 31, from 3-7 p.m. as the official hours for Halloween trick-or-treating. All local schools have been notified of the hours and will be encouraging their students to comply with the trick-or-treat hours. In addition, Villa Park Police Chief Robert Pavelchik stated that additional police personnel will be available to assist residents during the four-hour trick-or-treating period. Pavelchik encourages parents to make sure that their children trick-or-treat only during those hours.

Chief Pavelchik recommends that parents take a few simple steps to help ensure their children's safety during Halloween.

• Young children should be accompanied by a responsible adult. No child should ever

trick-or-treat alone. Children should walk only in well-lighted areas and avoid backyards, alleys, empty lots and parks.

• Make sure that any masks that are worn do not block a child's vision. They should be able to see well both in front and to each side.

• Children who trick-or-treat after dark should carry flashlights and use reflective tape on their costumes.

• Parents of older children should know the routes they are planning to take and set a time for kids to be home. It is strongly recommended that children go out in groups rather than by themselves.

• Review the contents of all treats. Remove any suspicious treats. If any treats show signs of possible tampering, call the police department at 630-834-7447.

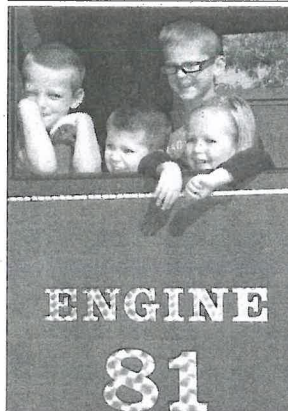
The improvements at the park will

### Rams lose to Geneva; Warriors and Broncos win

For the second straight week, one bad quarter dimmed the Glenbard East football team's chances for an important victory.

On Oct. 2, the Rams held a 26-12 halftime lead over South Elgin, but the visiting Storm scored 27 straight points in the third quarter on its way to a 61-47 Upstate Eight Valley Conference win in Lombard. Seven days later, the undefeated Geneva Vikings visited Glenbard East for a non-conference game. The Vikings erupted for 26 points in the second quarter on their way to a 39-21 victory.

Friday's loss to Geneva (now 7-0) sent the Rams' overall record to 4-3. Glenbard East needs to win its final two games of the regular season to lock up a berth in the IHSA playoffs. The Rams will travel to West Aurora (4-3 overall, 2-2 in the conference) for this Friday's Upstate Eight Valley Conference meeting. Glenbard East will finish the regular season with an Oct. 23 conference home game against Bartlett, which is now 3-4 overall and 3-1 in the UEVC.

"Going into the season, these guys wanted to be a playoff team," said Glenbard East coach John Walters after Friday's game. "We have two games left. You win them both and you're guaranteed a playoff spot. We don't have time to feel sorry for ourselves. We still have football to play."

The Rams took a 7-0 lead after senior quarterback Phil Abruzzino scored on a 1-yard touchdown run with about three minutes left in the first quarter. Geneva scored its first points of the night when it blocked a Glenbard East punt in the second quarter. The Rams recovered the loose ball in their own end zone, giving Geneva a safety that cut the home team's lead to 7-2. Glenbard East then punted the ball to the Vikings, who needed only a few plays to score a go-ahead touchdown. Moments later, Geneva blocked another punt and took possession of the ball inside the Rams' 10-yard line. A 4-yard touchdown run helped push the Vikings' lead to 16-7 with about eight minutes left in the first half.

The Rams also had two of their punts blocked in one quarter of their Oct. 2 loss to South Elgin. The Storm blocked two Glenbard East punts during the third period, when it outscored the Rams 27-0.

Abruzzino's second 1-yard touchdown run of the game helped the Rams cut Geneva's lead to 16-14 midway through the second quarter, but the Vikings responded by scoring their third touchdown of the period less than two minutes later. The Vikings kicked a 42-yard field goal as the first half expired to take a 26-14 halftime lead.

Geneva extended its lead to 33-14 following a 30-yard touchdown run in the middle of the third quarter. The Rams answered that score with Abruzzino's 63-yard touchdown pass to senior Mitch Luttrell with about five minutes left in the period. Junior Justin Murphy kicked the extra point to cut the Vikings' lead to 33-21.

The Rams' hopes for a comeback all but ended when they turned the ball over on downs at Geneva's 13-yard line with less than five minutes to play. The Vikings scored the game's last touchdown when they intercepted a tipped pass at the line and returned the ball about five yards across the goal line with less than three minutes to play.

"We knew this was going to be the toughest stretch," said Walters in referring to the games against South Elgin and Geneva. "In the last two weeks we've had four punts blocked and given up three interceptions to the defensive line. You're not going to beat good football teams doing things like that."

#### Willowbrook

The Warriors' road to the playoffs isn't complicated. They need to win their last two games of the regular season. If Willowbrook can beat Downers Grove South and Leyden to close out the season, they won't just qualify for the playoffs. They'll win the West Suburban Gold Conference championship for the first time in the program's history.

Willowbrook kept its post-season hopes alive with Friday's convincing 47-14 conference win over Proviso East in Villa Park. The Warriors held a 34-6 halftime lead over the winless Pirates, who dropped to 0-7 overall and 0-4 in conference play.

Willowbrook, which earned its second consecutive victory (the Warriors defeated conference rival Morton 38-31 on Oct. 2), improve to 4-3 overall and 3-1 in the WSGC.

Senior quarterback Billy Degnan fired six touchdown passes in Friday's win. Junior Jonathan Kelso hauled in

four touchdown receptions from Degnan, who threw one TD pass apiece to senior Ron Reitz and junior Freddie Clay.

The Degnan-to-Kelso connection accounted for Willowbrook's first two touchdowns, both of which came in the first quarter. The first scoring pass covered 12 yards. The next TD pass—a 15-yard completion on a third-and-six play—pushed the lead to 13-0 with less than one minute left in the opening period.

Degnan found Clay on a 10-yard touchdown pass with 8:36 to play in the second quarter. The Pirates scored moments later on a 70-yard run to cut Willowbrook's lead to 21-6. The Warriors responded with a 62-yard drive that ended with a 22-yard touchdown pass from Degnan to Kelso with 6:43 remaining in the first half. Willowbrook scored its fifth touchdown of the half shortly after the Pirates turned the ball over on downs at their own 28-yard line. Degnan found Reitz in the corner of the end zone on a 3-yard scoring pass to give the Warriors a 34-6 lead with 2:01 to play before halftime.

Kelso scored his fourth touchdown of the night on a 20-yard reception in the third quarter. Willowbrook scored its final touchdown on junior M.J. Ranieri's short pass to junior Mike Dembowski in the fourth quarter.

Willowbrook will enter this Friday's game against Downers Grove South on a two-game winning streak. The Mustangs (2-5, 2-2) have lost their last two games. They dropped a 21-14 decision to Downers Grove North on Friday. One week earlier, the Mustangs lost 28-24 to Leyden.

#### Montini

The Broncos didn't quite earn their fourth consecutive shutout, but they came pretty close. Montini held St. Francis scoreless for the first three quarters of Friday's battle between longtime rivals in Lombard. The Broncos coasted to a 27-8 victory to improve to 7-0 overall.

Montini had beaten its three previous opponents—De La Salle, Leo and St. Joseph—by a combined score of 121-0. Through seven games, the Broncos have scored 230 points and allowed just 46 points.

The Broncos will face the Fenwick Friars (3-4) in this

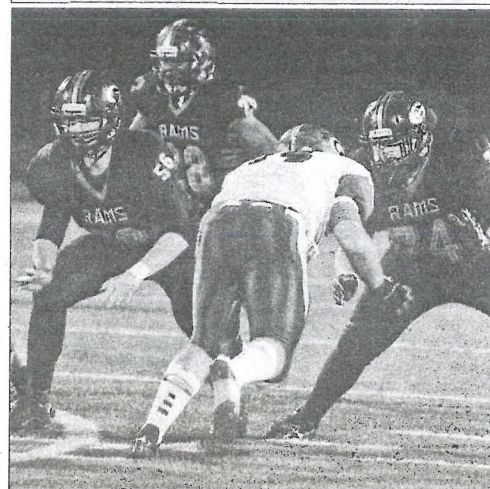
place from 7-9 p.m. each evening in Glenbard East's main gymnasium.

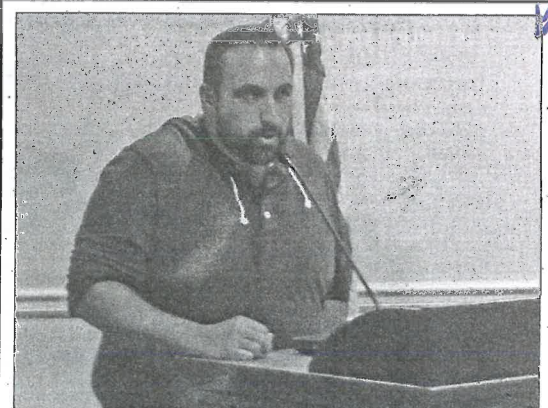

"Claudia's passion is telling stories, but she somehow always messes them up and

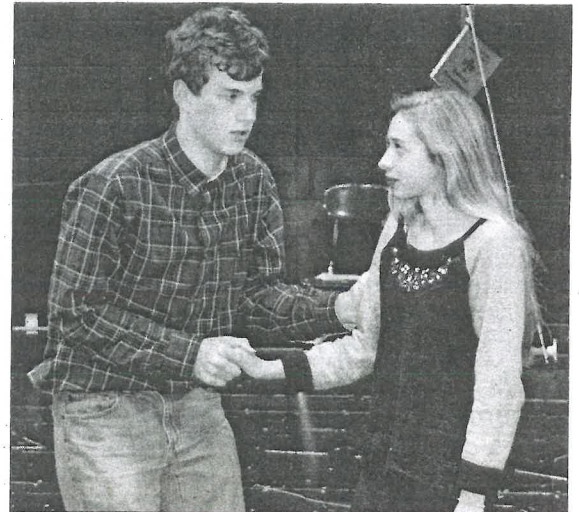
ends up interacting with the characters," Toay said. "I love Halloween, so I'm thrilled to be part of this show!"

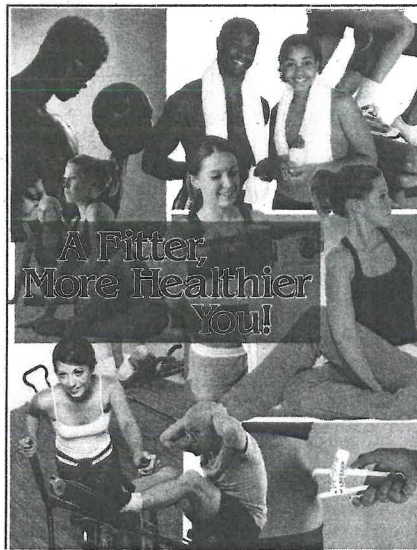

# First Folio Theatre to present Poe production

In a perfect confluence of place, script and talent, "The Madness of Edgar Allan Poe: A Love Story" creates a unique way to experience theater and the Halloween season in the entertaining clutches of First Folio Theatre.

The Mayslake mansion in Oak Brook belongs to the Forest Preserve District of DuPage County, but imagination and stagecraft transport the audience inside the home and haunted spirit of one of the great American writers. The love story of Poe and his doomed wife, Virginia, is spun between top-notch performances of some of his most famous short stories and poems.

Watching the play is no passive exercise for the audience, whose members move from room to room to view different scenes unfolding in main-level spaces of the atmospheric mansion, a fun tour in its own right. They'll also climb upstairs for a "Pit and the Pendulum" that will surprise with its intensity.

The superlative cast stars Christian Gray as Poe, and Heather Chrisler as Virginia, the gracious and fragile hostess who shares fascinating details about their relationship, while Kevin McKillip shines in "The Tell-Tale Heart" and "The Pit and the Pendulum." The set-

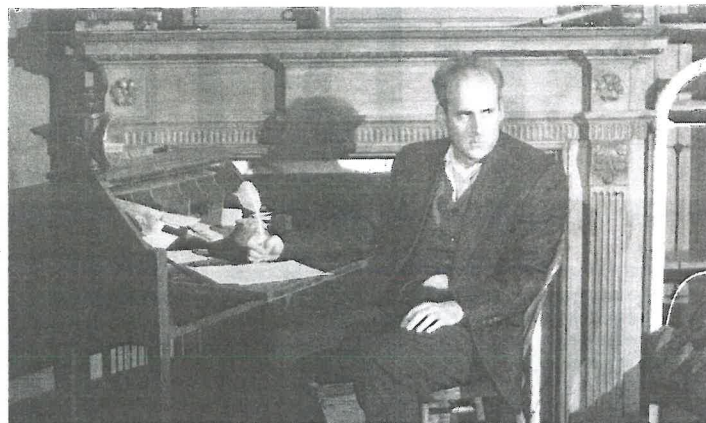

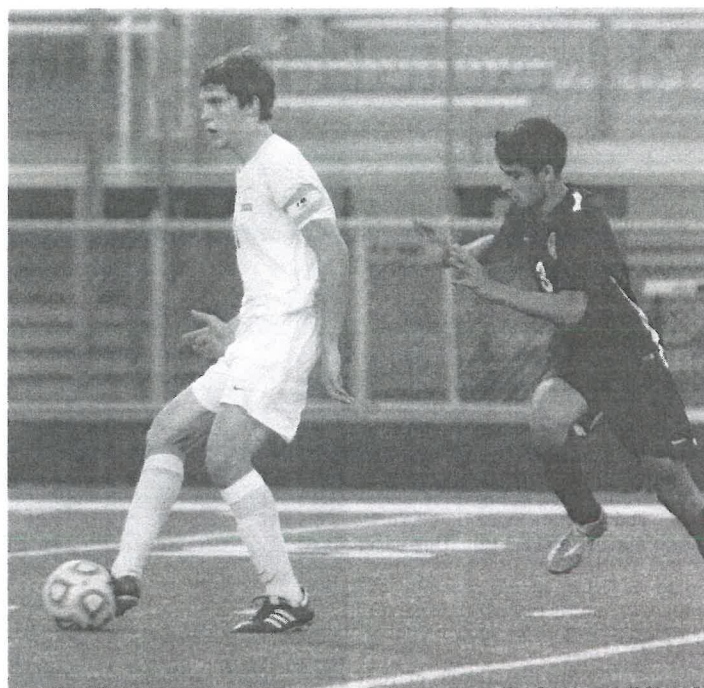
