Willowbrook defeated Bartlett 5-2 in the March 22 contest, which was called after five innings due to darkness and rain. Willowbrook opened its 2023 season with a 9-6 loss at Glenbrook South on March 21. The Warriors' season opener in Glenview was shortened to five innings because of darkness. Silvka pitched two innings for the Warriors during the home victory over Bartlett. Senior Alex Chaltin pitched the first three innings of the game for Willowbrook. Neither pitcher allowed an earned run. Chaltin, who gave up one hit, struck out six batters and issued three walks. Silvka, who allowed two hits, recorded two strikeouts and walked one batter. The Warriors improved to 2-1 with a 9-0 victory over Glenbard South at Lee Pfund Stadium in Carol Stream on March 27. Willowbrook sophomore Sam Marrese went 2-for-2 and drove in three runs in last week's win over the Raiders. Silvka went 2-for-2 and drove in one run. Junior Gabe Ness pitched the first four innings for Willowbrook in the shutout win over Glenbard South. Senior Eddle Munson pitched the final three Innings. Ness allowed two hits and struck out one batter. Munson gave up one hit and recorded seven strikeouts. The Warriors, who played a couple of games in Tennessee during their spring break trip last week, will open their West Suburban Gold Conference season with this week's three-game series against Downers Grove South. "The 3,251 current inmates who were sentenced prior to June 1, 2019, or Jan. 1, 2024, should have the opportunity (for parole review)," Lewis said in committee. "That is the essence of this bill."

The measure passed out of committee on a 7-3 vote and awaits action from the full House.

The push to abolish youth imprison-The push to aboust youth imprison-ment for his follows five U.S. Supreme Court decisions that found "children are constitutionally different from adults in their levels of culpability." One 2012 ruling found life sentences for those under the age of 18 violate the Eighth Amendment's prohibition on cruel and unusual punishment. Lewis' bill it the letter in a care of meavers. bill is the latest in a series of moves re-examining sentences for young people in Illinois.

The Rev. Lindsey Hammond, policy director at Restore Justice, a nonpartisan statewide organization that advocates for criminal legal reform, testified that juveniles are more capa-ble of rehabilitation as they "grow and

"Many people convicted of crimes as children and young adults will age out of crime and not commit crimes later in life," Hammond said. "People

who receive extreme sentences as children and youth are uniquely capable of change and therefore recidivate at extremely low rates."

Marsy's Law for Illinois, an organization that advocates for crime victims'
rights, testified against the bill. Jenkins said the bill as drafted doesn't do
enough to ensure victims or their families will be notified when an individual becomes eligible for parole.

"In the case of a retroactive change

In the case of a retroactive change in the law, you have to do it different-ly," Jenkins said in an interview. "You have to make sure that everybody that's going to be affected is found and notified and heard from."

Currently, the bill states the Prisoner Review Board must provide notice to the victims or victims' families by certified mail before the parole hearing

Jenkins said this wasn't enough, instead suggesting the court of origin should handle the notification rather than the Prisoner Review Board.

Committee chair and state Sen. Elgie Sims, D-Chicago, said there would need to be a commitment to continue conversations on the bill for the com-mittee to pass it.

Juveniles charged with possession of stolen vehicle, leading Villa Park officers on high-speed chase

of Police Mike Rivas announced that two Aurora juveniles, one of which was allegedly armed, have been ac-cused of leading police on a high-speed chase in a stolen car.

Both juveniles appeared recently at a detention where Judge Deme-trios Panoushis ordered that they be thos Fanousins ordered that hely be detained until at least their next court, appearance. One of the juveniles, a 17-year-old male, is charged with one count of possession of a stolen motor vehicle (Class 2 felony), one count of aggravated fleeing and eluding a police officer (Class 4 fel-ony) and two counts of misdemeanor reckless driving. The other juvenile, a 15-year-old male, is charged with three counts of unlawful use of a weapon (Class 4 felony) and one count of misdemeanor criminal tres-

count of misdemeanor criminal tres-pass to a vehicle.

On March 21 at approximately 9:55 a.m., a Villa Park police officer located a car that was reported stolen out of Naperville the previous day traveling eastbound on Roosevelt Road. The officer activated his emer-cercy lichts and attempted to pull

Road. The officer activated his emergency lights and attempted to pull over the vehicle, a Honda CRV.

It is alleged that instead of pulling over, the Honda fied from the officer at times reaching speeds in excess of 100 mph. It is alleged that the pursuit continued along I-88 and I-290 where the divisor with the express. where the driver exited the express-way on 25th Avenue. It is further al-leged that the pursuit ended when the

DuPage County State's Attorney CRV came to a dead end on Derby Robert Berlin and Villa Park Chief Lane in Westchester, at which time the juveniles fled on foot.

The juveniles were located in a barber shop approximately one quarter mile away and taken into custo-dy. Through the course of the arrest, officers located a loaded Polymer 80 9mm handgun without a serial num-ber, underneath a pile of wood along the route the juveniles allegedly ran when they fied.

It is alleged that one of the juve-

niles was previously in possession of the handgun and attempted to hide it from authorities when he fled. "We have seen time and again that

subjects allegedly in possession of a stolen vehicle will be in possession of a weapon to be used to commit more violent crime in our commu-nities." Rivas said. "Based on this repetitive behavior, and relationship between stolen vehicles and addi-tional violent crimes committed, the Villa Park Police Department will use every resource at our disposal to go after subjects in stolen vehicles.

"A stolen vehicle, fleeing from police at a high rate of speed, places everyone in danger in their path. We urge everyone to stop and pull to the right for emergency lights and siren for everyone's safety. We commend our police officer for his vigilance and bravery in pursuing the stolen vehicle in this case."

Bill aims to guarantee youth sentenced to life in prison a chance at parole after 40 years

Measure would extend recently signed law retroactively for all individuals sentenced while under 21

Illinois lawmakers advanced a bill
recently that would effectively abolish
life sentences for any incarcerated individual who was under the age of 21
when they received their sentence.
In January, Gov. JB Pritzker signed a
law that makes anytindividual who was

In January, 50% BF FIZEEF signed a law that makes any lindividual who was under the age of 21 when sentenced to life in prison eligible for parole review after they served 40 years or more of their sentence. But the measure only

applied to those sentenced on or after June 1, 2019.

Senate Bill 2073, carried by Republican Sen. Seth Lewis, of Bartlett, would extend the measure retroacwound extend the measure retroac-tively to apply to any currently incar-cerated individual who was sentenced before turning 21. The law signed by Pritzker in January takes effect Jan. 1, 2024, and SB 2073 would be effective July 1, 2024.

Willowbrook's Calli Kenny commits to Marquette

Willowbrook junior Calli Kenny, who led the high school program to its first sectional title as a sophomore and followed that with a 36-win season last fall, made a verbal commitment to Marquette on Monday.

Kenny joins a Marquette program coming off a 29-4 season and reaching the NCAA Tournament regional semifinals for the second time in school history after earning a Big East Conference championship.

This past fall, Kenny had a team-high 260 kills, 236 digs, team-high 79 aces (breaking her school record), 323 assists and 29 blocks.

Former congresswoman named new CEO at Little City

Former U.S. Ren. Marie Newman has been hired as the new CEO of Little City. Based in Palatine, Little City provides services to people with developmental and intellectual disabilities.



Newman will take the reins April 17 from CEO Shawn Jeffers, who is retiring after 20 years in the position, according to a news release from the agency.

Newman, a La Grange Democrat, represented Illinois' 3rd Congressional District from 2021 to 2023. After redistricting, she ran for the 6th Congressional

District seat and lost the Democratic primary to U.S. Rep. Sean Casten.

She has a bachelor's degree in journalism with a business minor from the University of Wisconsin in Madison.

Newman created a national coalition of 70 nonprofits to combat bullying after one of her children was bullied, which influenced a presidential executive order to require all schools to implement anti-bullying programs, according to the

"My personal dedication to Little City's mission dates to when I first volunteered with my family in my formative years for the organization and when two of my cousins received Little City's services," she said. "These memories are still vibrant and guide me today."
