Willowbrook's 4 x 100-meter re-lay team of senior Michael Wangler, sophomore Jaylin Miller, senior Joey Turnity and senior Noah Campbell also competed at the state meet. The four Warriors finished the race in 43.33 seconds during the state meet's preliminary heats and did not advance to the finals.

The top nine 4 x 100-meter relay teams from the preliminaries qualified for the finals. Willowbrook's foursome posted the 25%-best time in the event during the preliminaries.

Montini's season ended with a 2-1 overtime loss to Rock Island's Alleman Catholic High School in a super-sectional match at Benedictine University in Lisle on May 23. The Broncos completed their season with an overall record of 9-5-4. Alleman Catholic advanced to the Class 1A state semifinals with its victory over the Broncos. The Pioneers won their semifinal contest before losing 1-0 in overtime to Normal's University High School in the Class 1A state final on May 27. As a freshman, Gonzalez was a member of the Montini team that won the third-place trophy in the 2022 IHSA Class 1A state tournament.

## Bond set at \$100,000 for man charged with leading police on 150 mph high-speed chase

DuPage County State's Attorney Robert Berlin and Illinois State Police Troop 15 Captain Linda Mandat have announced that bond has been set for an Oswego man accused of leading police on a high-speed chase. Vermain Schaefer, 27, appeared at

vermain Schaeter, 21, appeared at a bond hearing, where Judge Margaret O'Connell-set bond at \$100,000 with 10 percent to apply.

Schaefer is charged with one count
of aggravated fleeing and eluding a
police officer (Class 4 felony) and
multiple misdemeanor and petty traffic offenses.

On May 22, at approximately 12:19 p.m., while performing speed enforcement measures in the area of 1-88 and 1-355, an Illinois State Trooper allegedly observed a motor-cycle, later determined to be driven by Schaefer, traveling at a high rate of speed at the Washington Street exit on westbound 1-88.

The officer activated his oscillating lights and attempted to initiate a traffic stop.

It is alleged that the motorcycle was traveling at 100 mph at this time. It is further alleged that instead of pulling over upon noticing the officer's oscillating lights, Schaefer

immediately, accelerated, reaching speeds of approximately 135 mph while weaving in and out of traffic.

The trooper on the ground did not pursue the motorcycle. Illinois State Police Air Ops monitored the motorcycle, which allegedly reached speeds of approximately 150 mph on westbound 1-88. It is alleged that after approximately 27 minutes, Schaefer exited the expressway and parked on Ramm Drive in Naperville, where he was taken into custody without incident.

It is further alleged that Schaefer did not have a valid driver's license.
"The allegations that Mr. Schae-

fer fled from the police at nearly 80 miles-an-hour above the posted speed limit are outrageous," Berlin said. "This type of behavior is extremely dangerous and puts the entire motoring public and the officers involved at great risk."

Schaefer's next court appearance is scheduled for June 20 for arraignment in front of Judge O'Connell.
